**WHO CAN PARTICIPATE:** Personnel Managers, Administrative Managers, Liaison Officers, HRD Managers and other executives engaged on responsibility of recruitment, reservation, welfare and redressal of grievances of employees belonging to SCs, STs & OBCs. **Office bearers of Associations of SCs, STs and OBCs may also attend.**

**FEE:** The programme is **Residential**.
